## INTRODUCTION AND INSTRUCTION:

People's Cultural Centre (PECUC) is a non gorvernment child rights focussed development organisation formally registered in 1990, with the purpose to empower the weaker sections of the socitey.

PECUC empowers children, women, elderly, youths & vulnerable communities to promote & protect their rights. Since the last three decades, PECUC has been continuously working for children, their parents, Grandparents, families & communities to empower & enable to lead a life of dignity. The proposed assignment is being conducted by PECUC in collaboration with Catholic Relief Services (CRS).

PECUC aniticipates awarding one (1) respondent as a result of this solicitation. PECUC reserves the right to award more than anticipated.

No communication intended to influence this procurement is permitted except by contacting the designated contact email provided below. ## SCOPE OF THE WORK/KEY DELIVERABLES:

The trafficking of children for labour exploitation is a gross violation of the basic rights of children enshrined in the UN Convention on the Rights of the Child (UNCRC). Child Trafficking for Labour in the state of Odisha is evident from the recent rapid assessment report<sup>1</sup> which distinctly projects that child trafficking for labour is a serious problem affecting thousands of children in Odisha<sup>2</sup>. The findings showed that it was not an isolated act, or occasional incident evolves out of a crisis than it has been built upon the long existent PUSH/PULL<sup>3</sup> factors. Children as young as 10yrs from remote villages of tribal districts of Odisha are more vulnerable to this crime and in the face of experiencing enormous physical, mental, emotional damages; and society at large suffers with prolonged poverty and adversities spread through generations. Triggered by Poverty, unemployment, underserving education system, familial disruption, disasters and social-cultural inequities, tribal districts of Odisha as source area feeds to the states of Andhra Pradesh, Telangana, Karnataka, Gujarat, West Bengal and Delhi as active destination points for these trafficked children. While children are migrating to several states, the proposed initiative is focused on children migrating to Telengana. Considering the extent of migration/ trafficking the two states have signed an MOU.

#### 1 Objective of the SOW:

The assignment aims to engage a consultant to lead the assessment by developing the methodology, a robust sampling plan, data collection tools, collecting quantitative and qualitative information from selected respondents, undertaking data analysis and report writing while managing coordination with the stakeholders.

On the other hand, Odisha is at number 6 in registering cases, but it has the maximum number of victims (1,475). In Odisha, out of 5,630 victims of kidnapped or abducted individuals in 2021, 5,192 (92.2%) are children. The tribal regions of this state are especially prone to child trafficking4. Poverty, lack of awareness, lack of employment opportunity are some of the predominant factors that make children vulnerable to the traffickers in this state. Children are trafficked from this state for forced labour, sexual exploitation and forced servitude. In 2021, as many as 653 people from Odisha were trafficked for the purpose of forced labour, the highest among all the states and Union territories, 44.97 per cent of the total victims who were trafficked for forced labour in the country5. They are not paid properly; no good accommodation is provided, and they are forced to work for several hours and under hazardous conditions. Children are trafficked to states like Telangana, Tamil Nadu, Delhi, and so on. The COVID-19 pandemic has worsened the situation as it pushed many families to extreme poverty. Besides, after lifting of the lockdown, factory owners have been tending to employ children as workers for cheap labour (Mohanty, 2021).

- III. Plan for field testing of tools
- IV. Outline a process for ensuring data quality assurance and confidentiality
- V. Data Analysis Plan
- VI. Desk research /Key Informant Interview (Information from relevant Stakeholders) on the issues of child trafficking for labour in Rayagada and Nabarangpur district
- VII. Mapping exercises Both on Family and Village level include Child/family Vulnerability, Existing Resources, (Support Services/ schemes and programmes) vulnerable area mapping within the two districts, Trafficking pathways Routes and communication medium or modes and Referrals.
- VIII. Progress reporting plan

#### 3 Key Products/Deliverables:

The selected consultant is expected to produce the following deliverables/products:

- 1. Data collection tools (quantitative & qualitative)
- 2. Raw data filled in survey form, Interview Notes, etc.
- 3. **Draft Report:** A draft report of the findings will be submitted to the PECUC for feedback (2-3 rounds of feedback are anticipated). The written report should clearly articulate the findings, conclusions, and recommendations (if any).
- 4. Final Report (containing the situational finding including gaps, challenges and opportunities and relevent recommendations) submission: The final report will incorporate comments and suggestions from the AIG. The report will be submitted in English, electronically. All the collected data (electronic) and audio recordings willbe submitted along with the final report.

#### 4 Proposed Timeline and Deliverables:

Duration of the Study: 60 days from the day of contract (Expected to be completed by the end of January 2024. The Technical proposal should capture how the agency will ensure that the study will be completed in the duration of 60 days.

#### Goal and Objectives of the Study/ assessment

An indepth analysis to findout the vulnerability of child/family, Existing Resources, vulnerable area mapping, Trafficking pathways and Referralsfor the 2 panchayats i.e. Dengaguda Panchayat in Papadahandi block of Nawarangpur district and Tadama in Rayagada block of Rayagada District.

Also overall vulnerability mapping and mapping of Trafficking pathways and Referrals of the two districts.

## Study Location/ Geography

The study targets 2 panchayats – one in Nabarangpur and other in Rayagada **METHODOLOGY:** 

The applicant consultant must review the existing documents and would come out with specific requirements for the study. This task includes the desk review of existing documents, collection of information from primary sources through FGD, Interview with rescued children and family, community leaders, Youth group Members, Women SHG leaders, Interview with grassroot level stakeholders, Key Stakeholders, Panchayatiraj Functionaries, Line departments etc

Development of format with relevant questionnaires for the collection of data both from the family, community and also from stakeholders
